At Topps Tiles we believe that having great people helps to create a great company. To successfully provide our customers with great inspiration, advice and service on their projects we aim to recruit, develop and retain diverse teams of people. We are committed to ensuring that all our roles are filled by the best candidate, irrelevant of gender, background or any other factor.

# **Topps Tiles**

## What is gender pay?

Gender pay gap legislation requires any employing entity with 250 employees or more to publish their gender pay for these employees. At Topps Tiles, we have one main employing entity - Topps Tiles UK Ltd – which covers all our store employees (c1,700) which we legally have to report on, however, all our employees (c2,000) are part of Topps Tiles plc which we are also choosing to report on here.

**Gender pay is different from equal pay**. Gender pay compares the average earnings of all male colleagues versus all female colleagues, irrespective of their individual role or seniority, whereas equal pay compares the pay a man and a woman both receive when doing the same or similar job. At Topps Tiles, we review all reward packages regularly to ensure we have fairness across all colleagues.

#### Our gender pay gap

The difference in the hourly pay for women compared to men in the pay period that included the snapshot date (5<sup>th</sup> April 2019)

Our gender pay gap has reduced to 3.8% and remains significantly lower than the UK average\* (17.3%). However, we still have a gap and this continues to be influenced by the demographic of our colleague population:

- 1. Length of service for our female colleagues has increased narrowing the gap between male and female colleagues.
  - There continues to be a correlation between length of service and pay
- 2. Part time roles remain predominantly female
  - 21.8 % (-6.6%) of all female colleagues are P/T vs 7.7% (-7.4%) of all male colleagues

# 3. More senior roles remain predominantly male

- 81.5% of our Store Manager and above roles are currently filled with a male colleague
- 26.8% of our Service Specialists, who account for c1,000 of our c2,000 employee headcount, are women vs 14.4% of our Store Managers

Bonus and incentives are an important part of our reward package we offer and all our colleagues have the opportunity to earn market leading bonus and incentives, irrelevant of their role. Our bonus gap figures are influenced by:

#### 1. The number of females vs males in senior roles

 Similar to many companies, our bonus opportunity increases with seniority and in the year to April 2019 our bonus gap was impacted by a number of share exercises at a senior level


## 2. Individual sales and store performance.

 Colleague bonuses and incentives are directly linked to how they and their store perform

# 3. Part time colleagues and new hires.

 The calculations are not pro-rated for hours worked, or length of service in the period year and it therefore takes time to build and realise their bonus and incentive opportunity

# Addressing our gender pay gap

The nature of our business has historically attracted more male colleagues than the overall retail sector, however over the past few years we have taken several steps to further improve our employee diversity by:

- Continuing to focus on our employer brand in the year to April 2019 we have increased our presence on platforms such as Glassdoor to give potential colleagues more insight into what its like to work at Topps
- Maintaining our market leading bonus and incentive opportunities for all colleagues
- Ongoing improvements in our working practices and policies supporting all colleagues:
  - In the Best Companies colleague engagement survey we were
    once again ranked One to Watch recognising our commitment to
    colleague engagement
  - Continuing to offer retail leading family friendly policies to help colleagues take time out of work to raise a family. We also offer colleagues the option to take a further week's unpaid holiday in addition to their existing holiday entitlement

All these steps have helped to increase our female representation across our business, for example:

- **24.76% of our colleagues are female** (+0.68% increase YOY)
- 72% of our store teams have at least one female in store (up from 69.3% prior year)
- Increasing the number of females in our senior leadership roles
